This letter is to contribute public comment in favor of the proposed Hill Top House Hotel project.

My husband and I live outside the town proper but within the greater Harpers Ferry address. As of this month, we have resided at this address 37-years. Almost daily we go into town for services such as the Post Office, library or a restaurant meal. As he does nearly every day, my husband has just left for a walk in town or on a nearby National Park trail or Appalachian Trail.

For too many years—decades now—we've lamented the woeful neglect of the Hilltop House. The years of wasted opportunity have been truly senseless. The SWAN organization should be credited for the patient persistence to fulfill their vision. The design they've developed is remarkable for numerous reasons: It embraces the unique features for which the town is so notable: its momentous history and geographic splendor. It's a breathtaking celebration of the world class overlook of the confluence of the Potomac and Shenandoah Rivers. The mindfully crafted concept honors the design of the original hotel, which should capture the interest not only of nearby guests but also international visitors. Strategically

located, it can take advantage of nearby transportation corridors and visitation from the Baltimore / Washington metropolitan region.

SWAN has amply demonstrated respect for and intent to address the needs and modifications sought by nearby residents to conform to limits imposed by the constraints of such a small town. It was 45 years ago. The Hill Top House Hotel was known to me previously as a quite special location. I decided that, given the opportunity, I would seek to utilize it for some excellent purpose.

At the time, I was serving as the Chief Research Attorney for a high-level National Commission of the American Bar Association. From around the country, a prestigious group of legal scholars, jurists, governors and other public figures, professors (including one from my alma mater, Harvard Law), etc. were brought together to meet at the Hill Top House Hotel for one of its group meetings.

Many of those persons also brought along their spouses. Some drove to Harpers Ferry from the airport, while others took the train from Washington, DC. We all spent several productive days in day-time meetings at the Hotel. The participants also toured the hill-side town, enjoyed going to the historical sites, made various food, etc. stops, and stopped to shop in the local stores.

On one of those evenings, I arranged for a hosted reception –with excellent hors d’oeuvres– on the front lawn of the Hilltop House Hotel. This superb site overlooked various vistas including the conjunction of the rivers, and mountains. (I understand that if approved, that site will remain open to the public, for their use and enjoyment.) I also very well remember an attendee’s comment: “It’s a great reception. But you outdid yourself in ordering up a Full Moon this Fall night.” While I had to chuckle, I deferred the “credit” to the Hill Top House.

When I was back to Harpers Ferry a number of years ago, I was surprised to see the obvious state of disrepair that this once fine hotel had sunken to. I also could see the “war of signs” in support of, or against, the proposal. I followed events occasionally through postings of area’s newspapers. There has been a great deal of economic short-sightedness. But more disappointing is how “democracy” is practiced –or perhaps not at all– by some politicians in this otherwise wise and wonderful WV town.

Remembering back –some “two score+” years ago– I am encouraged to hear that this facility might be reinvigorated and completely restored by a group of investors. Hill Top House Hotel should be restored to its former glory. It could be a tremendous asset, and an economic gain for all, once again.

If the effort for restoration is successful, this great facility will become the “new” premier resort for West Virginia. Hill Top House Hotel can, and assuredly will, once again attract an upscale clientele, with much-needed shots in the arms for the local and the State economy. There will be substantial economic benefits to result. There can be no question about proceeding further. ...Or to lose it all.

My family has operated a small hotel for the past 35 years in Bolivar just 1 mile from the Hill Top House Hotel. We serve mainly guests who are hike the Appalachian Trail, cycling guests on the C&O Canal Towpath and National Historical Park visitors.

Since 1986, we have seen a consistent decline in business due to many factors; decline in National Park resources, decline of in-person training at the Mather Training Center, fewer visitors to Lower town Harpers Ferry and a decrease in visitors to traditional annual events such as Olde Tyme Christmas.

We believe that a restoration of the Hill Top House Hotel will not only generate more interest to Harpers Ferry and surrounding area, but it will also invigorate and bring different demographics of visitors to this wonderful historic town for special events.

The Town of Harpers Ferry has been unable to find a pathway forward these past 14 years due to varying insular nature of opinions, and resistance to change, but we believe that moving forward is the best path economically to help ensure future viability of the Town. One need only look at the dilapidated building after 14 years of inaction to see the potential being squandered; a promise of renewed interest for future generations to explore beautiful and historic Harpers Ferry.

The Harpers Ferry – Bolivar Merchants Association has long been proponents of the SWaN group's vision to rebuild the historic Hill Top House Hotel. We have watched the hotel's continued deterioration while also watching the deterioration of our infrastructure, the rising cost of our water, as well as dwindling customer visitation rates since the Hill Top House closed its doors nearly 15 years ago.

Members of the Merchants Association have struggled to keep their doors open--through a pandemic, aftermath of fire, bad weather, and winters with few visitors--with the hope that the Town and SWaN could work together so that the Hill Top House Hotel would once again attract guests who would spend time and money in our businesses. To our chagrin, the Town of Harpers Ferry has been unable to find a pathway forward in nearly two decades due to oscillating opinions of two-year termed elected officials.

SWaN's vision of a new Hill Top House Hotel could potentially translate into \$360,000 in new annual revenue for the town of Harpers Ferry. That is money the town would have to spend on parks, the arts, beautification projects such as greenways, trails, highlight our paper streets, cultural events, and so many other needs. The spike in hotel-motel taxes from a new Hill Top could also mean another \$360,000 annually to spend on promoting tourism benefiting the entire county.

Swan's investment will provide an additional \$1 Million a year in tax revenue that can be used to maintain and improve our deteriorating public streets, sidewalks, and other infrastructure throughout our town.

The Merchants Association, which represents over 30 area businesses, requests your approval of SWaN's Tourism Development District application.
