### **Evidence of Previous Investment \***

Included is evidence that the applicant and/or affiliates of the applicant have invested at least \$10,000,000 in nonpublic companies in businesses located in counties within the United States with populations of 75,000 or less. Such evidence must indicate the name, location, and amount invested in the applicable business. The applicant must include supplemental information listing the counties where such businesses are located and their respective populations as of the most recent decennial census during the decade in which investment was made.

### **Business Plan and Revenue Impact Assessment \***

Attached is a business plan that includes a revenue impact assessment projecting state and local tax revenue to be generated by the applicant's proposed qualified investments, prepared by IMPLAN or REMI, using a dynamic economic forecasting model that analyzes the applicant's business plan in yearly increments over the ten years following the date the application is submitted to the department. Such plan shall include an estimate of the new jobs created and the jobs retained in the state as a result of the applicant's qualified investments.
